“CREATING A SPECIAL PRE-QUALIFICATION, BIDDING AND AWARDS COMMITTEE OF THE PROPOSED CONSTRUCTION OF SANITARY LANDFILL AT BARANGAY AGLALANA, PASSI CITY, ILOILO”

WHEREAS, the Sangguniang Panlungsod Resolution No. 2006-276 dated December 21, 2006 hereby created a Special Pre-Qualification Bidding and Awards Committee (PBAC) for the Proposed Construction of Sanitary Landfill at Barangay Aglalana, Passi City, Iloilo;

WHEREAS, mandated under R A 9184 is the creation of a special PBAC for special government project;

NOW THEREFORE, I, ELYZER C. CHAVEZ, City Mayor, City of Passi,, Iloilo, by virtue of the power vested in me by law do hereby order and direct the following;

SECTION II: Functions of the Special Pre-Qualification, Bidding and Awards Committee are the following:

Responsible to advertise and/or post the invitation to bid, conduct Pre-qualification of contractors, bidding, evaluation of bids, undertake post qualification proceedings and recommendation of awards concerning the proposed construction of Sanitary Landfill at Barangay Aglalana, Passi City, Iloilo in which representatives of COA, NGO, GTH-AHT, SWM4LGUs, DBP shall observe the procedure of such committee and shall certify that the rules and procedures for, bids and awards have been completed.

SECTION III: The local technical committee which provides technical assistance to the Special PBAC shall be the Sub-Project Implementing Unit (SPIU). They shall attend the meetings of the Special PBAC in order to present reports and recommendation of the local technical committee. The technical committee shall be lodged at the CENR Office.

SECTION IV: The attendance of the member of Special Pre-qualification, Bids and Awards Committee and Technical Group for the purposes of claiming or entitlement to the corresponding honorarium shall be suggested to the internal rules and regulations to be promulgated by Special Pre-qualification, Bids and Awards Committee to the end of the PBAC shall be efficient, transparent and effective.

SECTION V: Effectivity – The creation of the member of Special PBAC as herein provided shall take effect immediately.
